ALL SMILES DJ Fresh and Euphonik have a reason to be happy after their accused was ordered to pay their legal costs

woman who accused radio personalities Thato Sikwane (popularly known as DJ Fresh) and Themba Nkosi (also known as Euphonik) of sexually assaulting her has been ordered to pay their legal fees in a case of defamation of character that she brought against them.

The judgment which was handed down at the Johannesburg High Court on Thursday, seems to have created confusion between the parties involved, as the woman's lawyers and DJ Fresh took to social media to claim victory for the dismissal of

The judgment, which City Press has seen, stated in parts that the woman, who had filed the application in 2021, had her dignity violated when her cellphone number and comments about her were posted on a social media platform by Nkosi.

However, the application was dismissed with costs, as the judge found that there were other remedies that the woman could have exhausted before approaching the high court.

The judgment read: "The applicant's clear right is grounded in her constitutional right to dignity. The collective tweets by the first respondent consisted of a sustained attack on the applicant's dignity. The suggestion that the applicant was a liar and extortionist harmed her dignity. In my view, the applicant's reputation has been irreparably harmed." Judge Jacobus Strijdom also stated that, by the time Nkosi removed his Twitter post, the woman

had already suffered harm. The social media war between the two was sparked more than 10 years ago, when the woman accused Nkosi and Sikwane of having raped her. In response, the former Radio 947 host took to

his Twitter page and called her a liar and an extortionist. The woman then filed an application at the high court two years ago in which she demanded that

Nkosi publish an apology for his remarks about her on social media and pay her R500 000 in damages. The woman subsequently posted a remark in

isiXhosa, which is loosely translated as: "February is so long, it feels like January. I'm so broke."

Nkosi replied to this by posting: "LOL [laugh out loud], because being a liar and extortionist, a scammer and falsely accusing people you've never met isn't profitable ... Get help."

SEXUAL ASSAULT **ACCUSER FORCED TO**

War of words on social media between a woman and DJ Fresh has culminated in a court ruling in his favour

THE WOMAN FILED AN APPLICATION IN **COURT TWO YEARS AGO, SEEKING THAT NKOSI AND SIKWANE PUBLISH AN** APOLOGY AND PAY HER R500 000 IN DAMAGES FOR MAKING HARMFUL **REMARKS ABOUT HER ON SOCIAL MEDIA**

In another tweet by Nkosi a few weeks later, he posted a WhatsApp conversation that revealed the woman's cellphone number.

The post read: "On a serious note, before things really get out of hand, can this girl's family and friends help her before she hurts anyone else or herself? Unfortunately, my sister, you've said and done and damaged way too much to expect any level of help from me."

Strijdom held that the woman had had other remedies available to her, including applying for a protection order at a magistrates' court.

He concluded by ruling: "The applicant has not established the requirement of lack of an adequate alternative remedy ... As a result, the application is dismissed with costs."

Although Nkosi has not commented on the outcome, Sikwane took to his social media pages to celebrate the victory, declaring that the woman had been told to "go and jump". However, he later

The woman's lawyers and gender-based violence activists Wise 4 Afrika have released a statement saying that they had been instructed to appeal the

"Overall, we sought an interdict against Euphonik and DJ Fresh. The court acknowledged that [the woman's] reputation was indeed impugned and that she suffered harm. Furthermore, while relief wasn't determined in this judgment, we were ordered to seek the said relief from the [magistrates' court on a charge of harassment] instead, as that falls within its

"The legal team has been instructed to appeal some parts of this judgment pertaining to costs and the relief sought against Sikwane."

More creditors chase Koosimile, this time for R12k in KFC meals

Troubled businessperson Olivia Koosimile allegedly asked a friend to buy KFC Streetwise 2 meals worth R12 000 after she told him that she had won a tender to feed Electoral Commission of SA (IEC) officials in 2021.

Midrand-based businessperson Lindo Mphikeleli also transferred more than R200 000 in three separate transactions into Koosimile's personal Absa bank account in November 2021 as a loan, which she never paid back.

Mphikeleli is the third person to speak to City Press about Koosimile's trail of debt, which reveals that she seemingly sponsored her lavish lifestyle by asking for loans from close friends and business associates under the pretext that she was waiting for payment from tenders that never materialised.

Mphikeleli said that Koosimile had promised to return the money after 28 days, but she never did.

"As it stands, I have not seen her in a very long time. She has blocked me on WhatsApp and social media, and does not answer my calls or return any messages. The last time I called her for my money,

she blew up and screamed at me,

accusing me of harassing her," he said. Mphikeleli said he had met Koosimile through the ex-wife of a former soccer player when the businessperson was going through her divorce from popular

SuperSport commentator Baba Mthethwa. He said he felt pity for Koosimile when she told him heartbreaking stories about her divorce, which was straining her

"I met her through a mutual friend when we were both invited to the friend's golf day event at the Royal Johannesburg and Kensington Golf Club. She seemed like a nice lady and I did not suspect much of

He transferred R190 000 to Koosimile on October 12 2021, after she told him that she needed an advance to conclude the construction of an RDP housing project in Vereeniging, south of Johannesburg.

"I felt pity for her. She really seemed like she was going through a lot and I just wanted to assist her, as I had the money that she wanted. I did not charge her interest or make her sign anything. I trusted her," he said.

Mphikeleli also made transactions of R3 100 and R8 500 in the following

"She would call me sounding like it was an urgent matter. She [told me that she] needed money to sort out something

quickly and she would pay me back. "The first big amount she asked [for was to buy] KFC Streetwise 2 meals for IEC officials for a tender that she secured,

but did not [yet] have the money. "I drove to KFC in Kempton Park, where two of her assistants were waiting for me. I just swiped for the order and rushed out, and left them there to collect with her bakkie. She was not there, we only liaised through the phone," Mphikeleli said.

Koosimile's tone allegedly turned sour after he started asking for his money

"She started shouting at me when I enquired about the money and started being aggressive. I think she owes a few people that we used to play golf with. It's like she takes money from one person to pay the next, and takes money from the next person and pays the other. That is just how she operates. She will tell you a story about how she is waiting for money from a tender; it's her modus operandi."

Last week, City Press reported that Koosimile allegedly owes another Johannesburg businessperson more than R300 000 for a loan he gave her in

She was also accused of dodging debt collectors who were sent by Mpumalanga businessperson Sipho Phoku to collect more than R800 000 for a loan that she was advanced in September 2020.

City Press has attempted to secure comment from Koosimile on various occasions, to no avail.

2021/2022 WATER QUALITY REPORT for Greater Johannesburg Water Supply System

Johannesburg Water SOC Ltd, a municipal - owned entity of the City of Johannesburg, is mandated to supply water to the Johannesburg Metropolitan Area. The water supplied must meet the requirements of the South African National Standard for Drinking Water, SANS An extensive monitoring programme is followed to ensure compliance. This programme entails the analysis of at least 500 samples every

month, covering all reservoir zones, tower zones and informal settlements. During the 12-month financial year period from 1 July 2021 to 30 June 2022, 7227 samples were analyzed and 85592 tests were undertaken. Escherichia coli (E. coli) is the most important indicator of the microbiology quality of drinking water and SANS 241 requires at least 99% of samples to be free of E. coli. During the review period, 99.5% of the samples were free of E. coli. Turbidity measures the clarity of the water and according to SANS 241, 95% of the samples must be less than 1 NTU. During the review period, the turbidity in 99.4% of the samples was less than 1 NTU.

The average values of selected constituents, together with the maximum allowable values given in SANS 241, are as follows A full compliance statement is available monthly at:
