

# Mosimane agents insist they tried to reach out to Downs

We'll meet the club in court, says MT Sports

Tensions between Mamelodi Sundowns and their former coach Pitso Mosimane appear to be escalating daily, with his agency, Moira Tlhagale Sports Marketing and Management (MT Sports), confirming it had received a summons from Chloorkop to pay back agency commission in a multimillion-rand lawsuit yesterday.

Sunday World reported that Sundowns intend to sue MT Sports for about R8m after Mosimane left them in September to join Al Ahly, just four months after extending his contract.

MT Sports stated they it had been trying to get in touch with Sundowns to resolve the dispute, but was met with silence.

"It is with a deep measure of

shock and disappointment that MT Sports Marketing and Management has received a summons from Mamelodi Sundowns demanding to be paid back commission fees in lieu of coach Pitso Mosimane," read a statement.

"We have received communication from Mamelodi Sundowns and have attempted to reach an amicable solution to this matter. However, they have not responded to our request to meet with us.

"We attempted to speak to then club president Dr Patrice Motsepe in January this year and we were refused, and also last week with chairman Tl-

hopane Motsepe. We were met with silence."

Sundowns general manager Yogesh Singh could not be reached for comment.

Mosimane's contract was expected to run until May 31 2024.

"We hope sanity will prevail and that this will be resolved amicably. However, if this is not possible, we will be happy to meet Mamelodi Sundowns in court," the agency said.
